INSURANCE

Vendor must have a Certificate of Insurance showing proof of insurance with a minimum of \$1,000,000 valid through the event dates and Harley-Davidson of Erie, KSL Holdings, Inc., 3712 W. 12th Street, Erie, PA 16505 as certificate holder and description of operations as "Erie BikeFest", Event Dates July 14-19, 2020.

MERCHANDISE RESTRICTIONS
